## GRANT OF SPECIAL LOAN TO EMPLOYEES WHOSE HOUSES/PROPERTIES ARE DAMAGED AS RESULT OF NATURAL CALAMITY

(CAUTION: No particular scheme in this regard is in vogue. However, the following GUIDELINES are ordinarily followed).

**Authority** PC No.41/98 Dt.03-12-1998 To grant special loan upto the extent of two months of the concerned individual's Basic Pay or Rs.5000/-(Rupees five thousand only) whichever is less to employees whose house is situated at places, which have been declared as their home towns for the purpose

of LTC and were affected by natural calamity, subject to the following conditions:-

- a) The house should have been damaged badly as a result of the severe cyclonic storm.
- b) The house so damaged should be in the name of the employee/spouse/parents.
- c) The house/property that has been so damaged should be situated in an area notified by the State Government (concerned district collectors) as Natural Calamity, such as cyclonic storm affected area.
- d) The employee concerned should give an application (proforma at Annexure I) for grant of a special loan and should certify that his\her case satisfies conditions stipulated at (a) to (c) above.
- e) The employee should produce a certificate (Proforma Annexure- II) within two months from the Revenue Authority in respect of damage caused to his house/property as a result of Natural Calamity.
- f) The certificate mentioned in clauses (d) & (e) above will there after be got verified through the local revenue Authorities. If it is found to be false, severe disciplinary action will be taken against the employee concerned for making a false declaration. Further if the certificate is not produced within the time limit of two months or if it is found that the certificate produced is false, the entire loan out standing will be recovered with interest at 1% above the Bank Rate for cash credit to BDL in one installment.
- g) The rate of interest on the amount advanced will be decided by the Management.
- h) The principal amount of the loan sanctioned amount under **Authority** these orders will be recovered in 20 equal monthly PC No.42/98 installments and thereafter interest thereon will be Dt.09-12-1998 recovered in two monthly equal installments.



- i) If any special loan has already been sanctioned earlier, for the purpose of any Natural Calamity other that the present situation, the same will be adjusted against the special loan payable in the present circumstances.
- 2. The Concerned State Govt, shall intimate the affected areas.
- 3. Employees whose Home Towns are situated in such areas which declared as affected areas and who desire to avail special loan, may submit their applications, in duplicate along with their latest pay slip through Departmental Heads to the concerned Divisional P&A on or before the stipulated date for consideration and applications received thereafter will not be entertained.

Authority PC No.42/98 Dt.09-12-1998

**Clarification**: 1) The basic pay of an employee will be rounded off to the next nearest Ten rupees. For example, a basic pay of Rs.1918/- p.m. will be rounded off to Rs.1920/for the purpose of determining two months basic pay.

Authority PC No.43/98 Dt.15-12-1998 2) The employee who have not completed one year of service and not confirmed as on the date of issue of circulated notification will be paid advance as per the above terms provided that they submit a surety from a permanent employee. But, the following employees

are not entitled to this special advance.

- i) Those who are on deputation
- ii) Those who are on casual/contract/tenure employment
- iii) Those who are engaged on consolidated pay.
- iv) Apprentices/Trainees.
