# INTEREST FREE SPECIAL ADVANCE (FESTIVAL ADVANCE)

#### 1. INTRODUCTION:

A scheme for Festival Advance was introduced in 1972 which later replaced by a scheme for Interest Free Special Advance in 1991. The consolidated Rules in this regard was circulated vide Authority (Reference at SI. No.4 at the left) The rules in respect of Interest Free Special Advance as notified summerised as under:

**2.1** A sum of Rs.5000/- (Rupees five thousand only) will be granted to the employees as interest free special advance and the same is recoverable in ten equal monthly installments.

#### 3. **TERMS AND CONDITIONS**

All the permanent employees who have completed one year of service in the Company are eligible to draw this Interest Free Special Advance.



2) PC No.73 Dt.04-08-1976 3) BDL/04/83 Dt.25-07-1991 (Para 2.1 (a) (b)) 3.1 (b) The employees who are on probation are also entitled to draw this Interest Free Special Advance subject to the condition that they give surety of a permanent employee in the same Group/Grade.

## Clarification in respect of paras 3.1 (a) & (b)

The special Advance is admissible to all the permanent employees who have completed one year of service in the company. However, employees who are on probation even after completion of one year of

service in the company are also eligible to draw the advance, subject to the condition that they furnish the surety of a permanent employee in the same or higher group/grade.
