CIRCULAR

PC NO. 05/2011 dated 07 Jan 2011.

Sub: Grant of Monetary Award to employees and officers for acquiring higher qualification-reg.

In terms of PC No. 15/2010 dated 24 Jul 2010 and PC No. 29/2010 dated 11 Oct 2010, the Management is pleased to indicate that quantum of incentive payable as award for acquiring additional qualification would be doubled in addition to allowing reimbursement of final examination fee incurred by employees and executives with effect from 01 Jul 2010.

In furtherance to the same and keeping in view earlier circulars on the subject, it is to announce the list of qualifications for which such award and amount of award money that can be sanctioned for acquiring higher qualification.

- 2. The grant of incentive payable for acquiring additional qualification will be governed by the following rules:
 - i) The scheme is applicable to permanent employees of the Company, who have put in one year of service.
 - ii) The qualifying examinations, should have been taken up after joining BDL.
 - iii) The qualifications should be one recognized by BDL or the Government of India/State Government for appointment to its services.
 - iv) The qualifications should be one that would assist the employee to perform his duties better. Each individual case shall be examined in this light and recommendations of the Head of the Division shall be obtained.
 - v) The employee concerned should not avail study leave for acquiring the qualifications in question.
 - An employee desirous of claiming the monetary award under this scheme and registering his name with any University/College/Institution for the purpose should obtain prior permission of the Management to do so. The monetary award can also be availed by an employee, who held studentship of an Institution prior to his appointment in BDL and who declared the same on joining duty.
 - vii) If any employee who has received the monetary award is leaving the services of the Company within three years of receipt of the award will be required to refund the amount of award paid to him by the Company.
 - viii) These orders do not apply to deputationists, those employed on contract basis and to probationers.

- ix) An employee will be eligible to get such an award only once during his service career at BDL.
- 3. The list of qualifications as well as quantum of monetary award is given in the Annexure. The minimum incentive payable for acquiring higher qualification will be of ₹ 250/-
- 4. All employees who have registered their names with any University/College/Institution prior to the issue of this circular are also eligible for monetary award, if permission is accorded for such purpose under the existing procedure.
- 5. All cases henceforth will be processed in accordance with the guidelines mentioned above with effect from 01 Jul 2010.
- 6. Functional Directors are empowered to sanction the Monetary Award under the scheme.

This circular supersedes all other circulars issued earlier.
