Subsequently, the Government of India appointed Shri. Chetan Bansilal Kankaria as an Independent Director w.e.f 22 April 2025. Further, Shri Jashwant Lal ceased to hold office as an Independent Director w.e.f 24 February 2026. Consequently, the Audit Committee and Nomination and Remuneration Committee were suspended w.e.f 24 February 2026 due to lack of representation of Independent Directors on the Board of BDL. BDL is continuously following up with the Administrative Ministry (i.e. Ministry of Defence) for filling the vacancies. Currently, the appointment of Independent Directors is in the process at Department of Public Enterprises (DPE).
